The Insurance company will process the cancellation and refund according to their terms and policy.
 - (ii) The respective insurance company will be responsible for the cancellation and the refund process of insurance premium and the cancel & refund process will be subject to their policy.
 - (iii) No other related service & processing fee from GoCover.my will be refunded as the service is already rendered. (e.g. roadtax renewal processing fee or Delivery fee)
- 1.4. In the event of any issues on payment transaction (i.e.duplicate transaction, transaction error, etc.), You have the rights to raise a dispute.

- 2.3. Hardcopy policy will be made available at no cost for motor insurance customer who opt for Roadtax Renewal service.

 - (i) For policy more than RM1,000, no cost will be imposed.
 - (ii) For policy below RM1,000, RM10 will be charge for printing and delivery fee.

 - (i) Klang Valley address 1 business day from completed payment via our delivery staff (runner)
 - (ii) West Malaysia (Other than Klang Valley) 3 to 5 business days via Appointed courier service
